
An excerpt from "A Decade of Chronic Disease Management" — What is Case Management?



Case Management (CM) is an essential component of chronic disease management (CDM). While CMD is disease and population-centred, CM is patient-centred. This involves a clinical process that involves the timely coordination of quality healthcare services to meet an individual's specific healthcare needs in a cost-effective manner. To drive and implement CM, clinical pathways and protocols must be developed derived from evidencebased clinical practice guidelines. At the individual patient level, the goals of CM are to manage individuals at their maximum level of comfort, functionality and independence while at the lowest level of intensity of service. At the population level, the goal of CM is to create a platform on which to identify patterns and develop strategies to optimize health and enhance functional clinical and cost outcomes. Both of these goals are directly related to chronic disease management.
