Job/Practice Analysis of Case Management



The Case Management Society of Singapore (CMSS) was pleased to embark on a research study on the Job/Practice Analysis for case management and case managers across the health and social sectors. This research study will be the first local Case Management Job/Practice Analysis using the case manager's survey instrument on the roles and functions of case managers in Singapore. The main intent of embarking on a scientific Job/Practice Analysis exercise is to provide legitimacy and clarity to the practice of Case Management in Singapore, that is, to determine the actual and vital components of case management as it is practiced in Singapore. It will bring Case Management to the next level of prominence and to promote practice standards consistency through evidence-based developed Standards of Practice, Competencies and Training Curriculum We invited from USA, Dr Hussein M. Tahan, past Commissioner and Chair of the Commission for Case

Manager Certification (CCMC) and an expert in case management, to work with us to design a Job/Practice Analysis instrument; conduct a pilot test, perform a full survey online, analyse the results and complete a report on the survey findings, and implement the findings as appropriate. Dr Hussein was guiding our society in the past two years, in its revision of the Standards of Practice and develop Case Management Competencies, which was published as the second edition in Nov 2017. 23 subject matter expert (SME) from various hospitals, polyclinics and community agencies as well as AIC, participated this exciting journey to further develop the profession of case management in Singapore. A 4-day workshop to develop the instrument on the Job/Practice Analysis, took place in July 23-26 this year at the Kwong Wai Shiu Hospital.

A survey tool was developed and we have submitted a DSRB application to conduct the research. We do hope that when the survey tool is send to Case Managers in February/March 2019, they will actively participate in the research. Contributed by Ms. Margaret Hendricks
